Abstract

Drug addiction is one of the biggest problems facing any society, as the number of

addicts increases every year with the increase in the types of drugs and their negative

impact on young people and the way to prevent them, and their forms, as it has been

observed in the recent period that the phenomenon of addiction is no longer limited to

the rich only as it was in the past the matter has come to include groups of the poor

classes, and perhaps more than the number of rich addicts. In the past, drug use was

largely restricted to the male category, but now the female category is taking various

drugs, according to the latest studies.

Perception and feedback of MBBS students towards teaching the subject of pathology

Abstract

Pathology is a medical specialty that provides a scientific foundation for medical practice. It is important to keep evaluating teaching/learning methods to improve medical education. The present study was carried out using a questionnaire to determine the effectiveness of the followed didactic teaching learning method, mode of assessment and suggested new changes to improve the way of teaching. 112 MBBS students were asked to fill up predesigned questionnaire consisted of a set of questions having a number of options, on T/L methods and on the changes recommended. The collected data were analyzed using the statistical package of social sciences (SPSS). 48.2% of the students found the subject to be interesting and the most of students willing to do post-graduate study in pathology and agreed about importance of understanding pathology in clinical posting and integration of pathology with clinical. Only 1.8 % of students found general pathology to be a difficult subject. Majority of the students were satisfied with clinical correlation, content, proper highlighting and explanation are given to clarify the subject during lecture. A considerable proportion of students agreed that they were encouraged to asked questions, to matches their knowledge in general pathology with each body system and about the way of the delivery and demonstration of lectures. The majority of students satisfied with the number and duration of lectures, readability, usefulness and innovative methods during lectures. 47.3% of students agreed that didactic lecture is a very effective teaching learning method. The majority of students agreed with the viva voce examination, suggested the case scenario based questions and felt the strong need for introduction of integrated teaching, case based and group discussion. Only 27.7 satisfied with the introduction of computer-aided examination of tissue via digital image and 46.4% agreed about online learning. Majority of the students were satisfied with the present teaching learning method.

Reality of quality of higher education outcomes in southern governorates of Palestine in light of labor market requirements

Abstract

The study aimed to identify the quality of the outputs of higher education in Palestinian universities in the southern governorates in light of the requirements of the labor market. The tool of study was valid and reliable questionnaire to measure the quality and levels of higher education outputs in light of the requirements of the labor market, which composed of 50 items distributed in 5 domains: The qualitative quality of graduates, scientific literature and publications directed at community service, scientific consultations and projects, scientific research and conferences directed to society, and the university's relationship with community institutions morally and professionally. The study sample was composed of 264 members of academic staff of both sexes selected randomly from 4 Palestinian universities, which represents about of 51% of total study population of 552 members of academic staff of both sexes. The results show that reality of the quality of higher education outcomes in Palestinian universities as the relative weight of the total score for the quality of higher education outcomes was 62.40%. Regarding the level of meeting higher education outputs, the domain of scientific research and conferences directed to the community, and the domain of qualitative quality of graduates occupied the highest and advanced ranks among the rest of the domains, with a medium degree. While the domain of scientific literature and publications directed at community service and the domain of consultations and scientific projects were the lowest rank among the domains of the quality of higher education outputs in light of the requirements of the labor market and with a medium degree.

واقع جودة مخرجات التعليم العالى في المحافظات الجنوبية في فلسطين في ضوء متطلبات سوق العمل

الخلاصة

هدفت الدراسة إلى التعرف على واقع مخرجات التعليم العالي في الجامعات الفلسطينية في المحافظات الجنوبية في ضوء متطلبات سوق العمل، وقد استخدمت الباحثة المنهج الوصفي التحليلي، وكانت أداة الدراسة الاستبانة من المقننة صدقاً وثباتاً لمقياس جودة مخرجات التعليم العالي في ضوء متطلبات سوق العمل، وتكون الاستبانة من 50 فقرة موزعة على خمسة محاور (الجودة النوعية للخريجين، المؤلفات والمنشورات العلمية الموجهة لخدمة المجتمع، الاستشارات والمشاريع العلمية، البحث العلمي والمؤتمرات الموجهة للمجتمع، وعلاقة الجامعة بمؤسسات المجتمع أخلاقياً ومهنياً). أما عينة الدراسة فكانت مكونة من 264 عضو هيئة أكاديمية من الجنسين عبر الشبكة العنكبوتية من أربع جامعات فلسطينية (الأزهر، الأقصى، فلسطين، الإسلامية) في المحافظات الجنوبية، وتمثل 15% من المجتمع الأصلي للدراسة. توصلت الباحثة الى نتائج هامة، تشير إلى أن واقع جودة مخرجات التعليم العالي في المحافظات الجنوبية متوسط، حيث كان الوزن النسبي للدرجة الكلية لجودة مخرجات التعليم العالي هي 40.20%. بالنسبة لمستوى تلبية مخرجات التعليم العالي، تبوأ كل من محور البحث العلمي والمؤتمرات الموجهة إلى المجتمع ومحور الجودة النوعية للخريجين المراتب العليا والمتقدمة من بين باقي المحاور وبدرجة متوسطة، بينما كان محور المؤلفات والمنشورات العلمية الموجهة إلى خدمة المجتمع و محور المحاور جودة مخرجات التعليم العالي في ضوء متطلبات سوق العمل الاستشارات والمشاريع العلمية الأقل رتبة بين محاور جودة مخرجات التعليم العالي في ضوء متطلبات سوق العمل

Checkup of the potential natural resources abundance for a fishing trade in the reservoir lake of JabalAulia, Sudan

Abstract

This study checkup the abundance of the natural resources potential for the fishing craft in the JabalAulia reservoir lake, an applied study on the extension of the lake in the Kosti locality. This study aims to provide theoretical and scientific frameworks on the natural constituents of the fishing craft in the JabalAulia reservoir lake, and an attempt to clarify the importance and specificity of the components. The study found the existence of the Jebel Auliareservoir Lake, which extends about 630 km, with a water surface of more than 124,600 square hectares, with an average depth of 2.6 meters, and the width of the lake at the top of the storage ranges between 6-7 km, its capacity is estimated at 3.5 billion cubic meters, ideal limits for the presence of a number of the fish species in the lake of Jabal Aulia reservoir reach 54 species of fish out of 115 species belonging to 14 families of fish. The suitability of the components of natural construction and the abundance of production throughout the year made the fishing craft practiced by 77.5% of the fishermen permanently, and then the study recommended the need to preserve the components of natural construction and their protection from pollution and the incursion of activities that lead to the deterioration of the productive and consuming environment alike, the need to take advantage of the lake of the JabalAulia reservoir to settle fish production and expand production processes to shift from self-sufficiency to commercial production.

The feeding habits of total 366 and 384 specimens from males and females respectively of Marsupenaeus japonocus collected from Misrata Port, at the western Libyan coast, were investigated Samples were monthly collected in the period from March 2018 to February 2019. Monthly variation in the diet composition, the variation of the diet with length and the intensity of feeding were also examined. M. japonocus feed in a wide range of prey types, remains of fish, diatoms, remains of crustaceans, algal fragments, broken shells, debris, sand grains and foraminifera. There was no significant difference in the food composition of males and females M. japonocus. The quantitative analyses seasonally variations in the feeding intensity was quite high during the summer, autumn and winter.

Human papilloma virus detection in cervical smears of Jordanian women

Abstract

Cervical cancer is the third most common malignancy in women worldwide. Current screening programs use cytological smears as a mean of diagnosis. The classical Pap smear test is limited with respect to sensitivity and specify. The important role of human papillomavirus (HPV) infection in cervical carcinogenesis is now will established. Indeed, high risk HPV infection has been reported in 99.7% of cervical squamous cell cancer cases. It is also reported that the high risk HPV infection, and the activity of high risk HPV E7 oncoprotein, will result in the overexpression of p16 protein in cervical cells. So, pl6 immunostaining shows great promise as a marker of lesions associated with high-risk HPV, and it may assist in improving the reproducibility of diagnoses in cervical lesions including cervical cancer, allowing the early detection and management of such disease. However, there is no official record of the HPV prevalence among Jordanian women. Pap screening test is the current screening program used in Jordan as a mean of diagnosis. The aim of this study was to determine the prevalence of HPV in Jordanian females and to evaluate the use of Immunohistochemically detection of HPV and pl6 as a screening tool compared to the Pap smear test. Cervical swab samples were collected from 140 women attending local hospitals. This study supports previous reports suggesting the use of pi6 as a marker for high risk HPV infection. Furthermore, it highlights the prevalence of HPV infection in Jordan. Testing of HPV in combination with pl6 will be a valuable tool for cervical cancer screening, as these tests compensate the Pap smear testing limitations. These tests allow the early detection, management and follow up of women who are at risk for developing cervical cancer.
